AGENDA

Mr. Coleman moved to adopt the agenda as presented. Mr. Ferrell seconded the motion. All were in favor.

FINANCIAL REPORTS

Mr. Coleman moved to approve the financial reports for the month ending October 31st and the period ending November 12th. Mr. Ferrell seconded the motion. All were in favor.

Contract with Anthem for 2020 Health, Life, Optional Dental & Optional Vision

Department Reports

Fire Department – The Fire Department did not receive the FEMA grant. The Cardiac monitor needs replacing.

Resolution 2019-177

Purchase Monitor on a Five-Year Lease

Mr. Coleman moved to contract with Stryker for the lease/purchase of a cardiac monitor. Total cost is \$89,000. Mr. Ferrell seconded the motion. Roll call: Mr. Lang, aye; Mr. Ferrell, aye; Mr. Coleman, aye.

Chief Murphy said they need new hoses and can buy from Margaretta Township for \$1,500.00

Recreation – The equipment at Abernathy Park has been removed. A 5-year plan is to be developed. They are waiting on a contract with Cedar Point for the indoor center.

Public Works – They are still doing leaf pickups. The winter equipment was used for the recent snow fall.

Police Department – Chief Parthemore recapped the upcoming community events.

Community Development – Ms. Maloney reported on the monthly activities of that department. They have received grants from the Community Foundation for \$15,000 and ODNR for \$29,000 for playground equipment.

Zoning – Ms. Murray recapped the upcoming hearings for the Zoning boards.

Administrator – Mr. Boyle reviewed the recent meetings which he has attended and those which he will attend.
