**SPECIAL SESSION**

**May 19, 2020**

The Perkins Township Trustees met Tuesday May 19, 2020 in the Township Services Facility located at 2610 Columbus Avenue. Trustees present were James Lang, Timothy Coleman, and Jeffrey Ferrell. Chairman Ferrell opened the meeting with the Pledge of Allegiance at 8:00 a.m.

**AGENDA**

Mr. Ferrell moved to adopt the agenda as presented. Mr. Coleman seconded the motion. All were in favor.

**NEW BUSINESS**

**RESOLUTION 2020-61**

**Hire Ryan Printy as Intern for Community Development**

Mr. Ferrell moved to hire Ryan Printy as an intern in the Community Development Department at a rate of \$11.00 per hour with a starting date of May 18<sup>th</sup>. Mr. Coleman seconded the motion. Mr. Boyle said Ryan graduated with a degree in planning and will be attending graduate school in August. He will be working on neighborhood plans and surveying in Homeville and Searsville. **RESOLUTION 2020-62**

**Authorize Submission of Community Development Block Grant**

Mr. Ferrell moved to authorize the submission and acceptance of a grant to Erie County under the State of Ohio's Community Development Block Grant program. Mr. Coleman seconded the motion. Mr. Boyle said the application is due Friday. They will be applying for the maximum funds of \$30,000 for demolition purposes. The funds will not be available until 2021. Roll call vote: Mr. Lang, aye; Mr. Coleman, aye; Mr. Ferrell, aye. Resolution adopted.

**RESOLUTION 2020-63**

**Hire Donald Kreidler as Part-time Evidence Officer**

Mr. Ferrell moved to hire Donald Kreidler as a part-time Evidence Officer in the Police Department effective May 20, 2020 at a rate of \$12.50 per hour, increasing to \$13.00 per hour on January 1, 2021. Mr. Coleman seconded the motion. Mr. Boyle noted Mr. Kreidler will be replacing Mr. Wahl. Steve Westcott, who will be doing the training, noted that Mr. Kreidler is very detail orientated. Roll call vote: Mr. Lang, aye; Mr. Coleman, aye; Mr. Ferrell, aye. Resolution adopted.

**RESOLUTION 2020-64**

**Authorize Submission of 2021 SRO Grant**

Mr. Ferrell moved to authorize the submission and acceptance of the 2021 SRO grant. Mr. Coleman seconded the motion. Ms. Schaefer noted that the grant covers both SRO officers. Whatever expenses are not covered by the grant for the one position will then be billed to the Perkins LSD. Roll call vote: Mr. Lang, aye; Mr. Coleman, aye; Mr. Ferrell, aye. Resolution adopted.

Mary (Molly) Knight increase of \$0.50 per hour to \$11.50 per hour.
