REGULAR SESSION

October 26, 2021

The Perkins Township Trustees met Tuesday, October 26, 2021, in the Township Services Facility located at 2610 Columbus Avenue. Trustees present were Timothy Coleman, Jeffrey Ferrell, and James Lang. Chairman Coleman opened the meeting with the Pledge of Allegiance at 9:00 a.m.

AGENDA

Mr. Coleman moved to adopt the agenda as presented. Mr. Ferrell seconded the motion. All were in favor.

FINANCIAL REPORTS

Mr. Coleman moved to approve the financials for the period ending October 26, 2021. Mr. Ferrell seconded the motion. All were in favor.

PUBLIC HEARING

Mr. Coleman opened the hearing to consider an amendment to the Zoning Resolution to permit medical marijuana dispensaries as a conditionally permitted use in the "C-2" District, and to amend the Definitions and Supplementary Regulations section of the Resolution.

Ms. Blanco reviewed the proposed changes and the actions taken by the Zoning Commission.

John Pardee, Oberlin Ohio, is a patient advocate who is speaking in favor of this issue. As a result of a personal event, he has learned that medical marijuana is the safer alternative for medical care.

Mr. Ferrell moved to close the public hearing. Mr. Coleman seconded the motion. Roll call: Mr. Lang, aye; Mr. Ferrell, aye; Mr. Coleman, aye.

Resolution 2021-192

Amend Zoning Resolution to Permit Medical Marijuana Dispensaries

Mr. Coleman moved to amend the Zoning Resolution to permit medical marijuana dispensaries as a conditionally permitted use in the "C-2" District, and to amend the Definitions and Supplementary Regulations section of the Resolution. Mr. Ferrell seconded the motion.

Mr. Ferrell questioned whether this was only for the conditional use permit in the C-2 District. Ms. Blanca said that if a dispensary is conditionally permitted in the C-2 District, dispensaries would also be permitted in I-1 and I-2 Districts. Mr. Ferrell also clarified that this was for the dispensaries only, not the cultivation or growing activities. Then Mr. Ferrell reviewed the process, the facility would apply to the State for their license. If they are granted the license, then the facility would come back to the Township for the conditional use permit.

Mr. Coleman stated that the Township could put additional restrictions at later date, such as security. Ms. Blanca said that they changes would have to go back through the process of changes to conditional use permits.

Mr. Ferrell asked what the deadline was for applying for the license. Mr. Pardee said mid-November. Chris Visco, another representative of MMO, said that while they did not need the actual conditional use permit, they did need a letter from the Township saying that this location would be permitted for a medical marijuana dispensary.

Mr. Pardee said that one prohibition to the conditional use would be a drive through as many of their clients have mobility issues. Mr. Ferrell said that he was not totally in favor of a drive through facility. Ms. Visco, who operates facilities in Pennsylvania, said that with COVID they were dependent of the drive-through or curb side methods. She told the Board of the many security measures they have put into place with those facilities.

Mr. Pardee said they have the dispensaries in more progressive areas and the State of Ohio has looked at this from every angle to be certain in was safe.

Mr. Ferrell asked that this be sent back to Zoning to formalize the Conditional Permit stipulations so that they would be ready when someone receives their license. In Ohio there will be a set number licenses per district. Perkins is in the northwest district. The successful candidate(s) will be selected by a random draw from all applicants. Once selected, the applicants will be screened to see that they meet all the required qualifications. If not, they are disqualified and the next applicant is selected, again by random draw.

With no other questions, Mr. Coleman call for the vote on the motion. Roll call: Mr. Lang, aye; Mr. Ferrell, aye; Mr. Coleman, aye. Resolution adopted.

Mr. Coleman moved to amend Resolution No. 2016-169 to eliminate the prohibition on retail marijuana dispensaries. Mr. Ferrell seconded the motion. Mr. Ferrell questioned the use of the term "Retail". Ms. Blanca said that was the language used in the original resolution. Ms. Visco said that Retail is Medical. Mr. Pardee said that Ohio is only a Medical Use state. Roll call: Mr. Lang, aye; Mr. Ferrell, aye; Mr. Coleman, aye. Resolution adopted.

Appoint Joshua Powlesland as a Full Time Patrol Officer Class C

Mr. Coleman moved to appoint Joshua Powlesland as a full-time Patrol Officer Class C at a rate of pay of \$23.43 per hour (plus a 4% educational bonus), effective November 1, 2021. Mr. Ferrell seconded the motion. Chief Donald reviewed the hiring process and his educational background. Roll call: Mr. Lang, aye; Mr. Ferrell, aye; Mr. Coleman, aye. Resolution adopted.
