July 26, 2022

The Perkins Township Trustees met Tuesday, July 26, 2022, in the Township Services Facility located at 2610 Columbus Avenue. Trustees present were Jeffrey Ferrell and James Lang. Trustee Coleman was excused. Chairman Ferrell opened the meeting with the Pledge of Allegiance at 8:30 a.m.

AGENDA

Mr. Ferrell moved to adopt the agenda as presented. Mr. Lang seconded the motion. All were in favor.

FINANCIAL REPORTS

Mr. Ferrell moved to approve the financial reports for the period ending July 26, 2022. Mr. Lang seconded. All were in favor.

PUBLIC HEARINGS

Mr. Ferrell asked Jessica Gladwell to swear in everyone in who wished to speak at any of the hearings.

Mr. Ferrell moved to open the public hearing for the notice of declaration of insecure, unsafe, or structurally deficient structure and intent to demolish an accessory structure at 231 Dixie Avenue (ORC Section 505.86). Mr. Lang seconded the motion. Roll call: Mr. Lang, aye; Mr. Ferrell, aye.

Code Enforcement Officer Amanda McClain gave the history of this property.

Anna Johnson, Doerzbach, spoke on behalf of her mother and her sister. They are doing all that they can.

Jerrel Valliant, Shelby Street, is trying to buy the property on land contract and has plans to tear down the back half, redo the roof and siding. He would use it to store vehicles in the garage for his repair business. Ms. Byington noted that the property is not zoned commercially.

Mr. Ferrell moved to close the public hearing Mr. Lang seconded the motion. Roll call: Mr. Lang, aye; Mr. Ferrell, aye.

Mr. Ferrell said that this was the first step in the process. It is the intent to demolish; however, there is time to develop a plan.

Mr. Ferrell moved to declare an accessory structure at 231 Dixie Avenue as being insecure, unsafe, or structurally deficient, and intent to demolish pursuant to ORC Section 505.86. Mr. Lang seconded the motion. Roll call: Mr. Lang, aye; Mr. Ferrell, aye. Resolution adopted.

Mr. Ferrell moved to open the public hearing for the notice of declaration of insecure, unsafe, or structurally deficient structure and intent to demolish an accessory structure at 222 Doerzbach Avenue pursuant to ORC Section 505.86. Mr. Lang seconded the motion. Roll call: Mr. Lang, aye; Mr. Ferrell, aye.

Code Enforcement Officer Amanda McClain gave the history of this property.

Mr. Ferrell moved to close the public hearing Mr. Lang seconded the motion. Roll call: Mr. Lang, aye; Mr. Ferrell, aye.

Resolution 2022-140 Declare the Intent to Demolish – 222 Doerzbach Avenue

Mr. Ferrell moved to declare an accessory structure at 222 Doerzbach Avenue as being insecure, unsafe, or structurally deficient, and intent to demolish pursuant to ORC Section 505.86. Mr. Lang seconded the motion. Mr. Ferrell said that he has viewed this property. Roll call: Mr. Lang, aye; Mr. Ferrell, aye. Resolution adopted.

Mr. Ferrell moved to open the public hearing for the notice of declaration of insecure, unsafe, or structurally deficient structure and intent to demolish an accessory structure at 6412 Milan Road pursuant to ORC Section 505.86. Mr. Lang seconded the motion. Roll call: Mr. Lang, aye; Mr. Ferrell, aye.

Dale Coffman, representing David Hecht, said that they had been working with Paul Ricci, the former Code Enforcement Officer. It was their belief that the structures could remain on the property. Mr. Hecht has a financial hardship due to being on Social Security and has a financial plan in place with the Erie County Treasurer for property taxes.

David Hecht, Perry Street, said he had worked with Mr. Ricci to tear down the house after a fire. The cost of this demolition was added to his taxes. He would like to repair the buildings instead of tearing them down.

Dale Coffman said that they had recently dropped the price in the property to get it sold.

Mr. Ferrell moved to close the public hearing Mr. Lang seconded the motion. Roll call: Mr. Lang, aye; Mr. Ferrell, aye.

Mr. Ferrell asked if there were any agreement between Mr. Hecht and Mr. Ricci. Ms. McClain said that there was nothing in the files indicating any agreement. Mr. Ferrell asked Mr. Hecht and Mr. Coffman if they had anything. They asked if we had called Mr. Ricci. Mr. Ricci has retired.

Ms. McClain said that this has come about from a complaint from a neighbor in the summer of 2021. She then reviewed other records from them.

Mr. Ferrell repeated that this was the first step of an intent to demolish. Mr. Hecht said that he believed that the buildings were not unsafe. Mr. Hecht claimed that this action will bankrupt him. Mr. Ferrell said that they do not make these decisions lightly. Mr. Lang asked how long it would take Mr. Hecht fix the buildings. Mr. Hecht said that it has been difficult getting someone out to look at them. Mr. Boyle said that a compliance agreement would require funds to be placed in an escrow account.

Mr. Ferrell moved to open the public hearing declare 225 Gilcher Court a nuisance for vegetation exceeding 8 inches in height pursuant to ORC Section 505.87. Mr. Lang seconded the motion. Roll call: Mr. Lang, aye; Mr. Ferrell, aye.
