FINANCIALS

Mr. Ferrell moved to approve the financials for the month ending September 30 and the periods ending October 10 and October 24. Mr. Coleman seconded the motion. All were in favor.

Resolution 2023-170(B)

Declare 2006 International 7400 Truck as Surplus

Mr. Ferrell moved to declare a 2006 International 7400 truck, and related snow and ice control equipment as being surplus to the Township's needs and disposing of the same by the best available means.
